- Introductions: Welcome to Faizan as a new Student Ambassador to the team
- Previous minutes (June) approved by Laura and Rebecca
- Items:
  - SVP and Wellness Posters have been updated to reflect the feedback received. Ready to print. Laura will take to SRC and then move to printing.
  - Magnets – reviewed magnets for dorm fridges. Some feedback was given. Adjustments will be made and then move to printing. Discussion was had regarding including a list of support services/resources in the dorms as well (possibly on the back of the door) and/or on a key chain.
  - Fall 2024 Orientation and Consent Training at Residences. SVP will provide training to the Resident Advisors at Q-Hall on Aug 19<sup>th</sup>. Laura spoke about the intention to update the consent video.
  - Bringing in the Bystander – Three Student Ambassadors will receive the training in August. Once the class schedules are out in August, a timeline for Bringing in the Bystander training will be proposed. Trevor also noted that the new tutors will need this training as well. Laura will also connect with Ryan and Holly (SRC) about this training for their board members.
  - Flip the Script - still waiting to hear from the SARE Centre if we can collaborate on facilitating the program at St. Clair. Hope to hear back at the end of the month.
  - Swag – SVP swag has arrived. Still waiting on drink cover/hair scrunchies and a couple other items.
  - Events – provided some feedback regarding STORRY. Decision was made to put this event on hold due to concern related to student engagement. Discussed another possible event: Samantha Bitty. Team agreed to pursue the “Party Safer” event option by Samantha Bitty for the Windsor residences. Laura to connect with Samantha re: availability and connect with Gem. Furthermore, discussion was had regarding collaborating with SRC on events with strong student engagement (sexy trivia).
